

## Statement on "CZJUTAI" and privacy

Update date: September 14, 2021

CZJUTAI is Changzhou Jutai Electronics Co., Ltd. (hereinafter referred to as "the company" or "us"), which provides you with applications for controlling terminal equipment. We attach great importance to the protection of your personal information and privacy. We will provide corresponding security protection measures for your personal information in accordance with legal requirements and mature security standards in the industry.

### 1. Children's privacy related

We attach great importance to children's privacy. Although our app can be used by children, it can only be used under the supervision of a parent or legal guardian:

- a. We are pretty sure that APP users cannot interact with each other or exchange information
- b. We are very sure that the APP will not share the information provided by the user with third parties
- c. We are pretty sure that the APP will not provide the user's actual location information to other users
- d. We are very sure that the APP will not send advertisements to individual users with specific characteristics based on the user's Internet browsing behavior or use remarketing techniques (based on the user's previous application or website interaction records, Serving ads to individual users) Serving ads to these users
- e. We are very sure that the advertising content posted by APP users is suitable for children to watch
- f. We are very sure that the advertisements for these APP users comply with the family advertising format requirements
- g. We are very sure that the APP complies with all applicable regulations and industry standards related to child-oriented advertising
- h. We are very sure that the APP does not include: encouraging children to play on the store information page; beautifying the use of alcohol, tobacco products or controlled drugs; containing actual gambling or simulated gambling content; violent, bloody or thrilling content that is not suitable for children; Provide dating services or sex/marriage advice; the app contains website links and other content

### 2. Device permission call

- a. Allow apps to obtain location information based on network sources such as GPS, base stations, and Wi-Fi. This may increase power consumption. It is required for Bluetooth scanning connection. This is only required for application use. We promise that we will never obtain illegal access to your location information.
- b. Allow apps to use storage permissions. It is needed to save and obtain the local audio files. This is only needed for the use of the application. We promise that we will never obtain your storage information illegally.
- c. Allow the app to record audio permissions. It is needed for recording audio files. This is only needed for application use. We promise that we will never obtain your audio information illegally.

d. Allow apps to obtain positioning-related information: According to Android system requirements, users with Android 6.0 and above must enable positioning if they want to use the Bluetooth function. This is only required for the use of the application, and we promise that we will never obtain your location information illegally

e. Allow applications to access relevant network permissions: only for the iterative OTA upgrade of the device version, we promise that we will never obtain illegal access to your network permissions

### 3. Personal Information Security

We promise that we will never obtain any of your personal information during your use of the CZJUTAI application.
